Dear Shareholder

We write to you as a holder of shares in one or more of the Sub-Fund(s).

European Securities and Markets Authority (**ESMA**) has issued guidelines on funds' names using ESG or sustainability-related terms in their names (the **ESMA Naming Guidelines**) which will apply to the Sub-Funds from 21 May 2025. In order for the Sub-Funds to comply with the ESMA Naming Guidelines it is proposed to (i) change the name of the Sub-Funds and (ii) make certain amendments to the investment policies of the Sub-Funds to apply the EU Paris-aligned Benchmark exclusions to investee companies and the screening of sovereign issuers for the fixed income Sub-Funds.

The new names of the Sub-Funds are set out below for reference and further detail regarding the changes to the investment policies can be found at <https://www.dimensionalfunds.com/newsroom/irish-domiciled-dimensionalsustainability-funds-renamed-lower-carbon-esg-screened>. The changes will be reflected in an updated Prospectus of the Company on or around 14 March 2025.
